

Free Wedding Giveaway Official Rules

1. No purchase necessary to participate. Participants may enter by completing the web entry form located at www.hiltonestate.com. Entry forms require the completion of the statement: "In 250 words or less tell us about your most memorable romantic moment."

Limit: One entry per household. A bride and groom are defined as one household for the purposes of the Free Wedding Giveaway.

Copies of the official rules are also available at all participating hotels.

The 2012 Free Wedding Giveaway ("Program") begins at 6:00 a.m. Eastern Time on 1/15/2012 and ends at 11:59 p.m. Eastern Time on 2/21/2012.

2. Winner Selection Process:

a. All entries must have a legible, valid response to the question:

"In 250 words or less tell us about your most memorable romantic moment."

b. All entries must be received by each applicable participating hotel by no later than 11:59 PM on Feb. 21, 2012. All entries will be submitted to a person designated by Hilton Christiana, who will select the best ten (10) most romantic entries, to be known as finalists for each participating hotel.
